Minutes of the meeting of the Editorial Board of *Wisdom Speaks* held at its office at P. 867, Block 'A', Lake Town, Kolkata 700 089 at 6 P.M. on 23. 2. 2017.

Dr. Nupur Ganguly as the Editor chaired the meeting. At the outset, the meeting observed one minute's silence condoling the sudden and untimely demise of one of the patrons of INFAC the Hon'ble. Mr. Justice Altamas Kabir, former Chief Justice of India, who breathed his last on February 19, 2017. His intimate involvement with the activities of INFAC was narrated, for the members' acquaintance, by the Chairman of the Board of Trustees Shri Tapash Gan Choudhury. The meeting then proceeded as per the agenda as follows:

1. The meeting expressed its deep gratitude to His Excellency Shri Keshri Nath Tripathi, the Governor of West Bengal, for releasing the maiden issue of the journal to the public at large at a grand programme held on the occasion in collaboration with Indian Council for Cultural Relations (ICCR) at the Satyajit Ray Auditorium of ICCR on November 19, 2016, though the journal was officially published on October 20, 2016. The meeting decided to publish the thought provoking speech of His Excellency delivered on the occasion in its entirety at the next issue of the journal.

The meeting also thanked the other distinguished guests who remained present on the occasion.

The meeting expressed its deep gratitude to Shri Goutam De, Regional Director of ICCR, for extending the support of the ICCR in launching the journal through the collaboration programme and extending all support to make the programme a success.

2. The meeting hailed the efforts of the Convener in obtaining the ISSN for the journal from the concerned authorities of the Government fighting a pitched battle with the ISSN authorities and vowed to further upgrade its standard in line with the suggestions given by the members present.

3. On being proposed by the Editor and seconded by Prof. Dr. Sabyasachi Sarkhel , the meeting decided to induct Dr. Leena Taposi , Associate Professor and Chairperson of the Dept. of Music of the Dhaka University, Bangladesh, as a member of the Editorial Board of the journal and entrusted the Editor with the task of getting the consent of Dr. Taposi in the matter.

4. The issue of circulating the journal in various universities, both within and outside the country, was then taken up for consideration and it was decided that the members of the Editorial Board in their individual capacity will approach the authorities of concerned Departments of different Universities including their own to subscribe the journal and make request for recommending the same to the authorities of UGC for its recognition as a notified refereed journal of the said authority.

5. The meeting decided to meet at every one and half moth interval at the office of the journal for review of its progress. However, it was decided that the members of the Board staying abroad, if not available, may express their view on the agenda of the meeting through E-mail.

No other matter having remained for discussion, the meeting ended with a vote of thanks to the Chair.
