

### Conditions for Performing arts:

1. **Quorum** : A subject will be deleted / withdrawn from the contest in the absence of quorum . Option will be given to change the subject where quorum is not present. Intimation regarding withdrawal /deletion of any subject will be announced in Website 48 hours before the date of competition.  
If no option is exercised, fee received for the subject applied will be refunded on a date to be intimated later on.
2. **Restrictions:** (a) **Re. Accompanist Tabla player** - No competitor in vocal music will be allowed to bring any table player with him/her as an accompanist. A participant in vocal music will have to perform with the tabla player provided by the organisation.  
(b) **Re. Changing room** : Participants in dance competition will have to come prepared fully dressed. No facility of changing room will be available at the venue.
3. **Admit Card** : Admit Card will have to be downloaded from the Website . It will be made available in Website 48 hours before the date of competition.
4. **Result** : Decision of the empanelled judge is conclusive and binding on each candidate. Result will be Published in Website within a fortnight of holding the competition.
5. **Certificate:** (a) Each successful candidate will get Certificate. Save and except 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> position holders, certificates will have to be collected from the office of the organisation on the date and time to be announced for the purpose.  
(b) For outstation successful candidates, the certificates may be sent by post on payment of postal charges, as may be determined for the purpose.  
(c) Certificates for 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> position holders along with Memento will be delivered on stage on Prize Distribution Ceremony to be held on a date to be announced in Website.
6. **Stage Performance:** Subject to terms of INFAC Management, only the position holders of Senior and Junior Groups will participate at the stage performance to be held on Prize Distribution Ceremony.
7. **Amendment of Rules:** Rules of competition may be amended at any time at the discretion of the INFAC Management and the same will be binding on the competitors.

**Conditions for Visual art:**

1. **Quorum :** Participation in any Group may be withdrawn from the contest in the absence of quorum . Intimation regarding any such withdrawal will be announced in Website 48 hours before the date of competition.
  
2. **Mode of art work: Senior** (a) For Seniors painting on Canvas of the size 16"x20" inches using Acrylic medium; (b) painting material including Canvas to be brought by the competitor.  
  
**Junior & Sub-junior** (a) For juniors and sub-juniors, drawing on art paper of the size 14"x23" inches using sketch pencil or pastel colours; (b) painting material including paper to be brought by the competitor.
  
3. **Admit Card :** Admit Card will have to be downloaded from the Website. It will be made available in Website 48 hours before the date of competition.
  
4. **Result :** Decision of the empanelled judge is conclusive and binding on each candidate. Result will be published in Website within a fortnight of holding the competition.
  
- 5 **Certificate:** (a) Each successful candidate will get Certificate. Save and except 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> position holders, Certificates will have to be collected from the office of the organisation on the date and time to be announced for the purpose.  
(b) For outstation successful candidates, the certificates may be sent by post on payment of postal charges, as may be determined for the purpose.  
(c) Certificates for position holders along with Memento will be delivered on stage on Prize Distribution Ceremony to be held on a date to be announced in Website.
  
6. **Exhibition:** Senior Group candidate securing 1st position will get an opportunity to present his/her Painting at a concessional registration charge at the Annual Art Exhibition of INFAC.
  
7. **Amendment of Rules:** Rules of competition may be amended at any time at the discretion of the INFAC Management and the same will be binding on the competitors.
